1 EDIG@S XML 5.1 document guideline

This document describes in detail the contents of nomination, trade notification and confirmation documents exchanged between shippers, traders and transmission system operator (TSO) with Edig@s XML 5.1.

For exchanging documents, the TSO will use the internet combined with AS4 protocol.

Shippers and traders can communicate nominations and trade nominations with the TSO by logging in the TSO portal or by sending Edig@s XML messages via AS4.

In case of introducing a new version of Edig@s or new documents, the TSO will inform shippers and traders of the go-live date.

Edigas XML 5.1 documents supported in this document are the following:

NOMINT	NOMination INTention (detailed description)
NOMRES	NOMomination RESponse
ACKNOW	ACKNOWledge

NOMINT has two utilisation purposes in the Finnish gas market. Firstly, they are used for nominating shippers' gas quantities to be transported at Imatra Entry Point and Balticconnector Entry and Exit Points. Secondly, they are used for notifying the TSO about bilateral trades made by the market parties through the so-called virtual trading point.

2 Definitions

TSO	Transmission system operator with System Responsibility
VTP	Virtual Trading Point
EIC	Code given by Entsog or LIO (Local Issuing Office)
UTC	Universal Time Coordinated

An EIC code for foreign companies is provided by Entsog or the relevant LIO.

3 Nominations

Nominations are mandatory for shippers importing gas from Imatra Entry Point and importing or exporting gas at Balticconnector Entry or Exit Point. The respective messages are presented below.

Message type	Description
NOMINT 01G	The deadline for the receipt of shipper's Initial Nomination is before 13.00 UTC (wintertime) or 12.00 UTC (summertime) on the day before the Gas Day. The shipper may send a renomination NOMINT 01G every hour with a lead time of 2 hours. Renomination is allowed without initial nomination. Trade notifications are processed by the TSO starting from 13.00 UTC (wintertime) or 12.00 UTC (summertime) on the day before the Gas Day. The lead time for trade notifications after this is 30 min before every full hour.
NOMRES 08G	After receiving NOMINT, the TSO will send NOMRES 08G to the sender when the NOMINT has been matched with the sender's counterparty. NOMRES is sent every time there has been a change to the NOMRES.
ACKNOW 294	TSO sends an ACKNOW message in response to any received message. TSO expects to receive an ACKNOW message in response to any sent message within 10 minutes.

3.1 NOMINT 01G document

3.1.1 Start of document

The two lines below are the mandatory start of any nomination document.

3.1.2 Identification

The nomination document identification must be unique.

First document starts with version '1'. Subsequent nomination documents must be incremented.

3.1.5 Date format and time intervals

UTC date time format is used for all date and time fields.

The time interval of a nomination period requires at least one full gas day. More than one full gas day is allowed, as long as the message represents multiples of gas days.

Gas day (EET)	UTC	Time of year
07.00 – 07.00	05.00 – 05.00	During standard time (24 hour gas day)
07.00 – 07.00	05.00 – 04.00	During change from official standard time to daylight saving time (23 hour gas day)
07.00 – 07.00	04.00 – 04.00	During daylight saving time (24 hour gas day)
07.00 – 07.00	04.00 – 05.00	During change from official daylight saving time to winter standard time (25 hour gas day)

CreationDateTime is to be filled out as follows:

Market participant role is the role of sender. It will always be either TSO or the market party's own.

3.1.11 Measure Unit

The only measuring unit allowed in a NOMINT is KW1 (kWh/h).

Internal account is always the Finnish shipper's EIC code:

3.1.14 External Account

External account is the shipper's EIC code of the adjacent system, if Balticconnector is the connection point.

External account is the EIC code of the counterparty shipper or trader, if the connection point is VTP.

3.1.15 Time interval

Nominations must be sent in one hour intervals. All hours in the period must be included in the message time interval (e.g. up to 23, 24 or 25 periods in 1-hour intervals). There must be no overlapping hours. The recommendation is always to send a nomination for one complete gas day and not multiple gas days.

Example of a nomination for one hour of one gas day:

3.1.16 Direction

The nominating shipper must send a nomination direction as seen from the Finnish system point of view.

The TSO will respond by sending messages containing the direction as seen from the Finnish system point of view.

The direction is given by the codes:

Z02: ENTRY TSO

Z03: EXIT TSO

If the nomination value is 0 (zero), the direction code can be either Z02 or Z03.

Buying and selling at VTP or gas exchange must comply with the following:

Z02: ENTRY TSO, market party buying gas from counterparty or at a gas exchange

Z03: EXIT TSO, market party selling gas to counterparty or at a gas exchange

3.1.17 Quantity

Quantity is the quantity wished to be transferred by the market party. Values have to be positive or zero. Negative values are not allowed. Note that matching is done hourly therefore counterparts need to nominate similar hourly values to avoid lesser rule reductions in the matching process.

Shippers should note that quantities for nominations in Balticconnector have to be equal ("flat") for each effective hour of the gas day (effective hour = hours of the day for which a nomination can be effective excluding lead time).

3.2 Example document on NOMINT

The example NOMINT document is constructed as follows:

- Message contains all connection points and directions where the issuer is the same shipper.
- Message includes a period for each hour inside the account for one gas day.
- If the connection point EIC code is same for entry (Z02) and exit (Z03) and the internal and external accounts are the same for entry and exit there is only one connection point in the message.
 - contractReference: EIC code of recipient of the message, which is TSO in this case
 - issuer_MarketParticipant.identification: Finnish shipper's EIC code
 - issuer_MarketParticipant.marketRole.code: ZSH for Shipper
 - recipient_MarketParticipant.identification: TSO EIC code
 - recipient_MarketParticipant.marketRole.code: ZSO for TSO
- ConnectionPoint-identification: connection point EIC code, in this example message Baltic Connector Entry/Exit EIC codes are the same
- NominationType: A02
- Account-internalAccount: EIC code for the Finnish shipper
- Account-externalAccount: EIC code for the Finnish shipper's counterparty in the adjacent system
- Account has period for each hour with time interval, direction and quantity amount

3.3 Example document on ACKNOW to NOMINT

ACKNOW document is defined as follows:

- Message is sent as a response to NOMINT and NOMRES message
- TSO sends the response to NOMINT message and the market party generates and sends the message as a response to NOMRES message
 - type: 294
 - issuer_MarketParticipant.identification: EIC code of the sender of the message, so it is TSO or shipper depending of the direction of the message
 - issuer_MarketParticipant.marketRole.code: ZSO for TSO and ZSH for Shipper, depends of the direction of the message
 - recipient_MarketParticipant.identification: EIC code of the sender of the message, so it is TSO or shipper depending of the direction of the message
 - recipient_MarketParticipant.marketRole.code: ZSO for TSO and ZSH for Shipper, depends of the direction of the message
 - receiving_Document.identification: identification of the message (NOMINT, NOMRES) to which the ACKNOW is the response
 - Reason-code: 01G for positive message
